RE: OPRA Request – “Plans” respecting beach refurbishment/replenishment
Paula Hawks, August 1, 2011

Our office picked up the Beachfill, Absecon Inlet to Great Egg Harbor Inlet, Atlantic City to Ventnor City, Atlantic County, New Jersey, 90% Submission Plans prepared by the US Army Corps of Engineers (ACE) from the Mayor. We then reviewed same for accuracy of the location of existing modified and standard crossovers from the boardwalk to the beach. We also provided details of proposed “Modified Dune Crossovers” to the ACE. At the request of Commissioner Weintrob, we delivered the plans to Patti, the Mayor’s secretary, at the City Hall.

Our office did not pay a fee when we picked up the plans from the Mayor, nor did we charge a fee when the plans were delivered to City Hall. We have not reproduced the plans for any person or entity.
